Claim Reporting

Promptly notify Conner Strong & Buckelew of your claim

- Take the necessary steps to protect your property from further damage
- Document the damage and the steps you are taking
- Set aside damaged property for further inspection by your insurance company – do not discard it!
- Take pictures and/or video of the loss and all damaged property
- If your business is damaged, take the necessary steps to re-establish your business operations
- Track all claim-related expenses separately
 - Keep hard copies of documents & receipts. You may consider taking a snapshot of the documents and receipts with your Smartphone or camera
- If your business was damaged, consider establishing a separate, unique general ledger code for tracking these expenses. Costs to track include, but are not limited to:
 - All company labor used in the clean-up/rebuild (names and hours logged)
 - Outside contractors' labor & materials
 - Machinery and equipment rental
 - Supplies
 - Freight costs

- Document any projected loss of revenue and have your latest financials readily available.
- All documentation should be forwarded to your Conner Strong & Buckelew Claim Consultant.
